Rules for the processing of patient personal data by students of the Faculty of Medicine and Health Sciences (WLiNoZ) - ref.Z/1/2023, approved by the Faculty Council on 18.05.2023

These Rules are intended to protect patient privacy and ensure patient security and dignity.

These Rules apply to all students of the Faculty of Medicine and Health Sciences (hereinafter: WLiNoZ) during classes and placements.

1. Requirement of confidentiality:

a) Each WLiNoZ student is obliged to maintain confidentiality with regard to patient personal data, but also with regard to any medical information that may be disclosed in the course of working with patients during classes or placements.

b) A WLiNoZ student may only process patient personal data in order to fulfil the objectives of clinical classes and to the extent specified by the clinical class instructor or an authorised person. This data must not be used for purposes other than those for which it was provided.

c) Information obtained during clinical classes must not be shared with third parties without the patient's express consent or pursuant to applicable legislation. A medical programme student may only provide information regarding a patient's medical condition if this is necessary to meet the objectives of clinical classes or on the basis of the patient's express consent.

2. Liability for confidentiality breaches.

a) Breach of confidentiality rules or other provisions relating to the processing of patient personal data may result in disciplinary consequences for a student.

b) Breach of confidentiality rules by a WLiNoZ student will result in their liability under the Rules of Studies and the Higher Education Act. Furthermore, the student may incur civil or criminal liability under the applicable legislation.

3. Acknowledgement of reading the rules:

a) Prior to the start of the placement or classes, each student should sign a declaration confirming that they have read and agree to comply with the Rules on the processing of patient personal data.

b) Signing the declaration is compulsory and is a condition for participation in placements or classes.

Faculty of Medicine and Health Sciences student declaration on maintaining patient confidentiality

I will act in accordance with the principle of maintaining patient confidentiality, including in particular any sensitive data, and will always act in an ethical and responsible manner towards the patient and their privacy.

I am aware of the legal and disciplinary consequences if patient confidentiality is breached.
